Course Description and Objectives

This course is designed to cover advanced statistical topics for graduate students in social sciences as well as other disciplines. The course specifically deals with various topics in what is called as multilevel models.

The main goal of the course is to encourage the students to acquire a good and working knowledge of how the statistical analysis of data is conducted using multilevel statistical models. The course specifically offers an understanding of how such models work under various conditions. The course also concentrates on studying some of the potential drawbacks and limitations and how we can overcome them. However, due to time constraints, the course must selectively dwell on a limited number of specific models and modifications thereof.

The expectation is that by the end of the semester, three goals will have been achieved:

- (1) students should have improved their already acquired statistical skills in analysing and critically evaluating the quantitative professional literature using multilevel regression models.
- (2) students should be able to design and carry out statistical projects that employ multilevel modelling techniques for testing substantive theories.
- (3) students will become better equipped to explore and study more advanced statistical models and techniques in future projects.

Therefore, the course is a hands-on learning experience organized every week in two sessions. One session will consist of a lecture and discussion of the major theoretical notions and approaches of the course. A second session will consist of a **collective** learning through direct group discussion and practice of the ways on how to use Stata to analyse multilevel data. Students are required to attend both sessions and are required to come prepared to pro-actively participate in both sessions.

Requirements and Assessments

The requirement for this course is simple: work diligently and persistently. This includes attending classes, doing the readings carefully before the class meets, and working regularly on homework sets and a research paper. Each student should expect to be spending many hours learning how to excel in using the Stata software commonly used to estimate the models discussed in class.

There will be a number of homework assignments from the Stata book that the students must complete and turn in canvas. The homework assignments are due on specified dates; no late submission is acceptable. In addition, the students are strongly encouraged to solve some of the other exercises at the end of each chapter of the Stata book. This is a good way to put into practice the concepts and techniques learned in each chapter as well as provide yourself with much needed practice to effectively understand and master the learned statistical skills.

A major component of the course assessment will be a term research paper. Each student is expected to produce a manuscript of high quality using an appropriate modelling strategy. I will work closely with the students on their projects.

Distribution of Grades

- 1. <u>40%</u>: Weekly graded sets of exercises from the stata book. All assignments are to be uploaded to canvas before the beginning of class on their respective due dates. No late submission will be accepted for any reason (except when justified with university sanctioned documentation).
- 2. <u>10%:</u> Each student will be assigned "presentations" for the practice session of the course which will consist in presenting the weekly assigned readings from the stata book (this will be fully explained on the first day of class).
- 3. <u>40%</u>: A Research paper on a topic/published paper chosen by the student in consultation with the instructor. The goal is to produce a high-quality manuscript, using a model (or models) discussed in the course. See down below for details.
- 4. <u>10%</u>: Each student will present his/her research paper at a date and time which will be set by the instructor. The presentation will consist of a ppt presentation followed by Q & A.

Computer Requirements

All models covered in this class will be estimated using the Stata software package. You can use the UF app for stata provided by the university or your own copy of stata. The use of a different statistical package is possible upon consultation with/permission from the instructor.

Specifics on the Research Paper

In order for the instructor to provide adequate and timely feedback in the preparation of this paper, you will be required to turn in various brief intermediate papers throughout the semester. The students have one of two options:

1. For students who are already writing their dissertations:

A student can opt to fulfill this requirement by carrying out a statistical analysis that falls within his/her dissertation using a multilevel-models approach. This will be done in close consultation with the instructor. The completed paper will ultimately consist in writing one chapter of the dissertation. The same deadlines as stipulated in the following apply to this option for fulfilling the research paper requirement.

2. For students who are not yet in the stage of writing their dissertations: Each student must:

- Find a published paper that interests you and that applies a statistical method comparable to the material covered in this course (that is, using a multilevel-methods approach). Note that the focus should be on the methodological aspects of the paper and not on the substantive question. The purpose of the assignment is that you train yourself on methods and not on learning more on the substantive question addressed in the paper (although that is also part of the research in itself, especially for those who are writing a chapter of the dissertation in this project). Due Date: January 30th one-page summary of the chosen paper/topic.
- Obtain the data from the authors (or from elsewhere). Due Date: February 13th one-page report.
- Replicate the published or produce (for those working on their dissertation) results as nearly as possible. **Due Date:** March 13th submit a multiple-page report.
- You must extend/deepen the analysis in some way. You could, for example:
 - Suggest a more appropriate functional form for the estimation and re-estimate.
 - Argue that one or a set of important variables were omitted and conduct the analysis anew.
 - Argue that the results are likely to be sensitive to sample selection or variable measurement etc. and then conduct appropriate analyses to address that possibility.
 - o Extend the data or use a different data set to test the theory.
 - o Any other good, feasible idea that you come up with.
- The final product should be about 15-20 pages long, including the bibliography. Due Date: April 17th.
- Prepare a ppt presentation at the date and time set by the instructor.
